Proposed Board Action:

(1) Amend the approved FY 2012 – FY 2016 Texas A&M University System Capital Plan to add the Physical Education Activity Program (PEAP) Facility Project for Texas A&M University (Texas A&M) with a FY 2012 start date and a total planning amount of \$21,000,000.

(2) Appropriate \$2,100,000 for pre-construction services and related project costs.

Project Justification:

The Department of Health and Kinesiology is currently located in the Read Building beneath Kyle Field and G. Rollie White. When these buildings are razed to accommodate the Kyle Field renovations related to safety issues, the department will lose about 227,000 square feet of office, classroom, lab, and activity space that houses the department's administrative offices, the Kinesiology Division, the Health Division and the Physical Education and Activity Program (PEAP). About 112,000 square feet of activity space is located in these facilities and much of this space is shared with the Department of Athletics, the Department of Recreational Sports, and Student Activities after 5 pm and on the weekends. The PEAP program alone teaches about 25,000 students in classes each semester and thousands of additional students utilize the facilities for recreational activities each day before and after scheduled classes. The space needed for PEAP activities is unique and not available in any other facilities on campus.

The proposed PEAP Facility Project will house approximately 111,000 gross square feet of office and activity space. The facility is intended to serve as the permanent home for the PEAP classes and will support the formal activity class needs of students. In support of the continuing partnership between the Health & Kinesiology Department, Recreational Sports and the Athletic Department, the PEAP Facility Project will be designed to accommodate a portable lay down flooring system to

provide three indoor tennis courts when needed. The growth in the offerings of the Recreational Sports program for students could be supported in part in this facility on a scheduled basis in the evening and on weekends.

Scope:

The PEAP Facility Project will be located on a site on the west side of Penberthy Boulevard just north of the existing Mitchell Varsity Tennis Center. The general site is shown on the map with this agenda item. The actual location will be based on a master plan of the site area performed as part of this project to also include an indoor tennis facility and a Health and Kinesiology Academic Professional Building.

The PEAP Facility Project is planned as a two floor pre-engineered steel structure containing approximately 111,000 gross square feet.

As currently envisioned, the facility will include:

- + Multiple activity rooms for dance, fencing, gymnastics, yoga, pilates, self defense
- + Multi-use gymnasium
- + Weight rooms
- + Badminton courts doubling as basketball courts
- + Men's, women's and faculty locker rooms
- + Classrooms
- + Faculty, staff and general administration offices
- + Support spaces

The PEAP Facility will also be designed to accommodate a portable lay down flooring system for three tennis courts.

The exterior of the facility will be a mix of masonry and metal panels and will be compliant with the Texas A&M Master Plan.

Current plans call for completion of the PEAP Facility Project in summer 2013. A more definitive project scope and budget will be determined during the pre-construction phase and approved by the Board prior to the construction contract award.

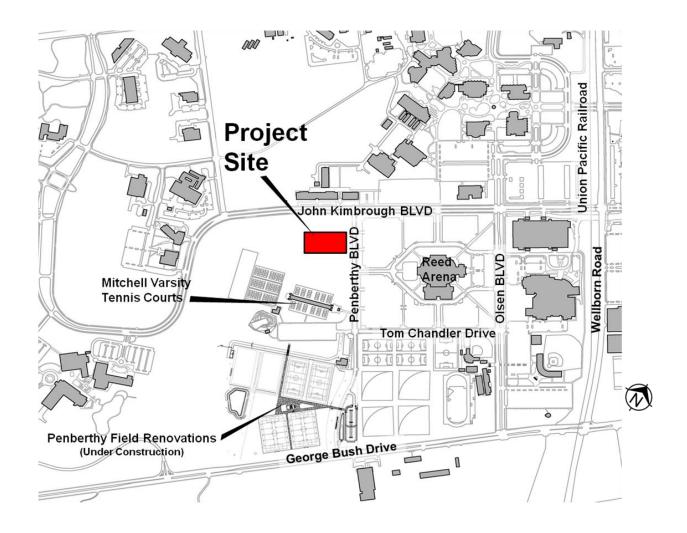

(1) Amend the approved FY 2012–FY 2016 Texas A&M University System Capital Plan to add the Kyle Field District Plan Phase 2 Project for Texas A&M University with a FY 2012 start date and a total planning amount of \$16,000,000.

(2) Appropriate \$1,600,000 for pre-construction services and related project costs.

Project Justification:

The Athletic Department will continue the development of the Kyle Field District Plan. This continuation will have three components including a Sports Nutrition Center, an expansion of the Bright Building lobby, and the construction of a new branded entryway to the Bright Complex that will include the elimination of the Omar Smith Tennis Center, with a replacement of the parking area and a new entry from George Bush Drive. This new drive will connect to a newly constructed plaza which includes the relocated John David Crow statue.

The Sports Nutrition Center is for the benefit of all student athletes but will be open to the general student body per NCAA rules. The proposed location is the patio of the Bright Building adjacent to the Nye Academic Center. This facility will house a general dining area along with several breakout rooms for special functions, food preparation areas, storage areas, and staff offices.

⁺ The 12th Man Foundation has agreed to guarantee the \$1,600,000 for pre-construction services.

The Bright Building Lobby expansion will extend the lobby out to the new plaza and John David Crow statue. The expansion will include a new two-story grand entryway to the Bright Building capable of housing 150 people and mainly used for recruiting functions.

The proposed branded entryway will connect the new plaza in front of the Bright Building to George Bush Drive. The new drive will require the elimination of the Omar Smith Tennis Courts. This will then allow a larger parking area that can be used by the Texas A&M Foundation and the Athletic Department. This will necessitate the re-centering of the John David Crow statue into a new plaza.

The estimated cost for the project is \$16 million. This project will be completely funded by donations through the 12th Man Foundation. The initial request is to put this project on The Texas A&M University System Capital plan. The 12th Man Foundation has agreed to fund the initial 10% pre-construction service amount which will allow for design to commence.

Scope:

The Kyle Field District Plan Phase 2 Project will include an addition to the north side of the Bright Building to house a Sports Nutrition Center of approximately 13,000 gross square feet, an addition to the south side of the Bright Building to expand the lobby of approximately 3,000 gross square feet, a plaza, parking lot and entry drive. The building additions to the Bright Building will include the following spaces:

- + Dining facilities
- + Multipurpose room
- + Fresh market servery
- + Kitchen/food preparation area
- + Mechanical space
- + Storage area
- + Lobby expansion
- + Staff offices

The Kyle Field District Plan Phase 2 Project will be designed and constructed to conform to the Kyle Field District Plan and the Texas A&M University Master Plan.

Current plans call for completion of the Kyle Field District Plan Phase 2 Project by August 2013. A more definitive scope and budget will be determined during the pre-construction phase and approved by the Board prior to the construction contract award.
