Subject: Approval of the Project Scope and Budget, Appropriation for Construction

Services, and Approval for Construction for the New Taxiway G and Aircraft Rescue and Fire Fighting Access Road Project, Texas A&M University,

College Station, Texas (Project No. 2-3073)

Background and Prior Actions:

The New Taxiway G and Aircraft Rescue and Fire Fighting (ARFF) Access Road Project was included as an approved project on the FY 2012 – FY 2016 System Capital Plan approved by the Board of Regents at the July 2011 meeting.

Proposed Board Action:

- (1) Approve the project scope and budget.
- (2) Appropriate \$4,444,000 for construction services and related project costs, subject to project approval by the Texas Higher Education Coordinating Board (THECB).
- (3) Approve construction of the New Taxiway G and ARFF Access Road Project at Texas A&M University (Texas A&M), subject to project approval by the THECB.

Project Justification:

Taxiway G will be used to move aircraft between Taxiways E and H without crossing Runway 10-28. Currently, an aircraft moving between Taxiways E and H is required to cross, or taxi down, Runway 10-28. As the airport continues to develop, the west side of the field will see much more aircraft traffic. Taxiway G will remove one of the most likely danger spots for runway incursion at Easterwood Airport. In addition, the design and construction of an ARFF vehicle road will allow access to the west side of the airport for a quick response to any west side emergencies.

Ninety five percent (95%) of the eligible project costs will be funded from FAA discretionary funds based on unused entitlement funds remaining from other airports. Texas A&M's five percent share of these project costs will be provided through the Airport Operations Fund. Texas A&M can reimburse itself for its five percent share of the eligible cost from revenue collected through the Passenger Facility Charge (PFC) program. Construction will take place only as FAA funding is available.

Scope:

The new Taxiway G and ARFF Access Road Project is located on the southwest side of Easterwood Airport as shown on the location map with this agenda item. The project will construct:

- Approximately 1450 feet of 50 foot wide concrete pavement for Taxiway G to connect Taxiways E and H including lighting and signage.
- An approximate 700 LF extension of the asphalt perimeter ARFF access road to Taxiway E.
- Major culvert facilities for creek crossings on both the taxiway and access road.
- Storm drainage inlets and piping

Competitive sealed proposals for construction of the project were received on September 7, 2011. Construction is currently scheduled to begin in January 2012 and reach substantial completion in March 2013. The total project budget is \$4,444,000.


