 - Big red binder in the main office of each campus
 - Filled with information specific to that campus/facility
 - Includes a broad range of emergency situations and how to respond accordingly
 - Inclement weather/natural disasters
 - Armed intruder situations
 - Medical situations
 - Emergency notifications with contact information

- Major Activities/Program Scope
 - Drills to cover these response options:
 - Evacuation (fire drill)
 - Site Evacuation
 - Reverse Evacuation
 - Lock Down
 - Duck and Cover
 - Safe Shelter in Place

- Program Scope
 - Evacuation Bags for each campus
 - water
 - first aid kit
 - flashlight
 - candy (diabetic)



- Program Scope
 - Safety Inspections each year for every campus
 - Fire Alarm Systems
 - Fire Sprinkler Systems
 - Fire Extinguishers
 - College Station Fire Department
 - Insurance Company

- Program Scope
 - Actual emergency to respond to
 - This one was a fire at AMCHS
 - Evacuation went perfectly
 - CSFD complimented our processes
 - Back in class within two hours

Staffing

- All individuals are responsible for participation in this critically important function in addition to their other duties
- One SRD on each high school and middle school campus, including Wellborn Middle School next year

- Performance Data for the past year
 - Spring of 2017 Safety and Security Audit
 - Results were very positive
 - Staff was well prepared
 - Drills were being performed and documented correctly
 - Transition from CSPD to BCSO has been fairly smooth, with some coordination needed
 - No significant security problems to note
