SUBJECT:

Authorization for the Administration to Award a Contract to Collier Construction for the New Agriculture Building on the Blinn-Brenham Campus

RECOMMENDATION:

That the Board authorize the Administration to award a contract to Collier Construction for the new agriculture building on the Blinn-Brenham Campus.

RATIONALE:

At the November 13, 2018, regular meeting, the Board authorized the Administration to seek Competitive Sealed Proposals (CSP) from contractors for the new agriculture building. The Administration received responses on April 18, 2019, from five contractors. The Administration reviewed these proposals for contractor qualifications and pricing. Based on these factors, and upon the recommendation of the architect, the Administration recommends awarding a contract to Collier Construction. Collier Construction's base bid of \$1,164,260 is under the \$1,200,000 budget for construction. Collier Construction also provided three alternate bids totaling \$114,050. The Administration recommends awarding a contract to Collier Construction for the total of the base bid and three alternate bids in the amount of, \$1,278,310. The Administration further recommends that the Board authorize the use of an additional \$78,310 from the 2016 series bond funds for the additional cost.
