Taxpayers and others interested are invited to attend and be heard at this time.

Said budget is filed with the County Clerk and will remain on file in the office of the County Clerk, in accordance with existing statutes. Taxpayers and others interested are urged to acquaint themselves with the said budget during the time it remains on file with the County Clerk before the hearing.

The proposed budget includes funding for a cost of living increase, merit pay and longevity pay for all eligible employees of Brazos County. The proposed salaries of elected county and precinct officers are as follows:
