Meals will be served “curbside” between designated times. They will be able to pick up lunch for that day and breakfast for the next morning. Students may pick up from any of the sites listed.

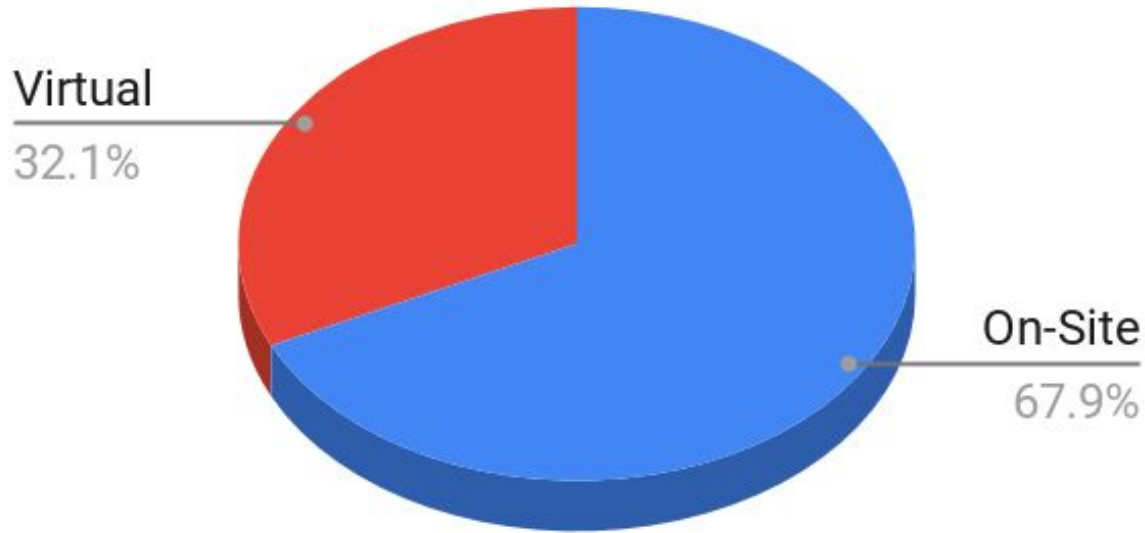
Transportation
