Summary: This contract is for the design of a new Facilities Maintenance office building and workshop to be located near the current Public Works Operations Center off of W. King Cole Dr. Currently, the division uses a portion of the old fire station located at 1207 Texas Ave as office and workshop space. The scope of this project is to construct a 7,000 sf metal building to be used as office, storage, and workshop space.

Budget & Financial Summary: Budget in the amount of \$900,000 is currently appropriated for this project in the Facilities and Technology Capital Improvement Projects Fund. A total of \$148 has been committed or spent to date, leaving a balance of \$899,852 for this contract and future expenses.

Project Description

The City of College Station is relocating their Facilities Maintenance Division. They will be moving into a new building on William King Cole Drive. This will be a new 7,000 sf building. It will include drive thru bays, work area, office space, restrooms, kitchen or break room, site and parking lot improvements. The construction budget is limited to \$1,000,000. With the limited budget, the building will be basic in design and materials. It is anticipated to be a pre-engineered metal building with limited masonry to pass the City's UDO. It will be constructed with a CMAR contract. The construction manager has not been selected. The construction of the project is to be completed by the end of 2021.

Scope of Services

The Architect shall provide Architectural, MEP, Structural, and Civil Engineering services. Geotechnical report and survey are included. This includes Schematic Design, Design Development, Construction Documents, Bidding/Negotiation/Permit and Construction Observation services. Structured Cable System design (data and telecom), Audio/Visual design and Security System design are included. It is anticipated that the existing detention pond will be expanded or a new facility provided. This proposal includes analysis of the existing drainage facility as required to accommodate the new project. The anticipated schedule is as follows; note that the survey work cannot begin until January 4, 2020:

Pre-Design: authorize survey and geotechnical report: 2 weeks.

Programming and Schematic Design: 4 weeks

Design Development: 3 weeks

Construction Document Phase: 6 weeks

City site plan review: 4 weeks Pricing and Permit: 4 weeks

Construction Administration: 8 months

We anticipate the billing schedule to closely relate to the design schedule as follows:

Schematic Design 20% of fee
Design Development 15% of fee
Construction Documents 40% of fee
Pricing and Permit 5% of fee
Construction Administration 20% of fee over 8 months

The schedule does not include city review/approval time, nor does it include time to resolve potential issues related to UDO (desire to have simple rectangular PEMB design will not meet the UDO).

Fee Proposal

PROPOSAL: City of College Station Facility Maintenance Building

We propose to provide architectural services for a fixed fee of \$145,175. The fee does not include reimbursable expenses. Reimbursable expenses may include parking, long distance telephone calls, copies, cost of AIA contracts, and Texas Accessibility Standards drawing review required by the State. Reimbursable expenses will be invoiced at 1.15 times their actual expense incurred. Reimbursable expenses will not exceed \$5,000 without prior authorization in writing from the Owner. Invoices will be sent monthly, proportionate to the work accomplished and are payable within 15 days of the date of invoice. The fees for additional Architectural services, if requested in writing, shall be based on the following hourly rates: Principal Architect \$165; Project Architect \$125; Project Lead \$95; Technician \$80; Project Intern \$65; and Administrative \$60. The fees for additional engineering services will based on their hourly rates. Additional services will not be performed or invoiced without written authorization. We are prepared to start the work within one week after receipt of the executed contract.
