Services, and Approval for Construction for the RELLIS Campus Infrastructure – Phase III-A Project, The Texas A&M University System RELLIS Campus,

Bryan, Texas (Project No. 01-3323)

Background and Prior Actions:

The RELLIS Campus Infrastructure – Phase III-A Project was included as an approved project on the FY 2021 – FY 2025 A&M System Capital Plan approved by the Board at the August 2020 meeting.

Proposed Board Action:

- (1) Approve the project scope and budget.
- (2) Appropriate \$13,177,885 for construction services and related project costs. \$1,234,800 has been previously appropriated.
- (3) Approve construction of the RELLIS Campus Infrastructure Phase III-A Project for The Texas A&M University System (A&M System) at the RELLIS Campus.

Project Justification:

Development of the RELLIS campus proving grounds infrastructure on the west side of campus is required to support the Ballistic, Aero-Optics, and Materials (BAM) Facility and the Bush Combat Development Complex (BCDC): Innovation Proving Ground (IPG) projects, among other future development. Currently, the major campus infrastructure extends only as far as the

BCDC. Infrastructure extensions will include electrical, fiber, and domestic water and some sanitary sewer; additional work includes storm water improvements to accommodate storm water drainage to the affected areas associated with the BAM and IPG projects and improved drainage to the Brazos River outfall structure.

Scope:

Project scope includes utility extensions (electrical, fiber, and domestic water) aligned with Runway 35L from the current termination at the BCDC just north of the Runways 4/10 crossing to near the RELLIS Campus and Knife River property line. Sanitary sewer will be extended to the South under the 4/10 cross of the runways. Utilities will be underground and include appropriately spaced manholes. Fiber cabling to support the 5G network is included. The project also includes phase one of the storm water improvements, which will accommodate necessary drainage for proving grounds impacted by the BAM and IPG projects. Improvements will include regrading, installation of new storm water piping, and vegetation removal. A future project Infrastructure III-B will complete the utility and storm water improvements for the remainder of the RELLIS innovative proving ground.

Construction on this project is scheduled to start in June 2021, with substantial completion scheduled for June 2022. The total project budget is \$14,412,685.

Deferred Maintenance:

There is no deferred maintenance associated with this project.

Other Major Fiscal Impacts:

None.

Strategic Plan Imperative(s) this Item Advances:

RELLIS Campus Infrastructure – Phase III-A supports Strategic Plan Imperative 4, "The A&M System will increase its prominence by building a robust and targeted research portfolio. We will continue to encourage cross-institution and cross-discipline collaboration, and we will support our member institutions in their research pursuits, including obtaining emerging research status." This project is essential by providing the required infrastructure (electric, fiber, domestic water) and accessibility to the BCDC: IPG and the BAM which are critical in supporting Army Future Command's research priorities. This project additionally addresses the storm-water drainage requirements which is essential prior to construction.

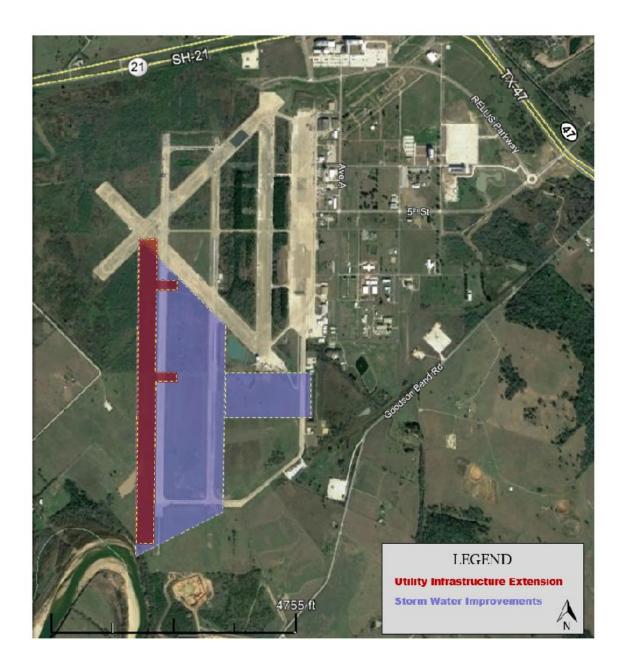
