Good afternoon Mr. Greer,

Please use the description Ms. Anderson provided for the previous Commissioners Court agenda. The Eagle Newspaper legal notice is attached to ensure we are following Texas Department of Agriculture protocol as it relates to revising the Herbicide Regulations County Special Provisions.

"Section 7.53 (f) of the Texas Herbicide Regulations County Special Provisions <u>Herbicide Permit</u> requirements revisions will be discussed and voted on at the upcoming Brazos County Commissioners Court meeting on November 16, 2021 at 10:00a.m. The meeting will be held in the Commissioners Court at the Brazos County Administration Building, 200 South Texas Avenue, Bryan, TX. 77803."

The revised Brazos County Special Provisions should be updated to read as follows:

7.53 (f) BRAZOS. That portion of Brazos County lying east of the Brazos River and west of the following described line shall be regulated by the Act, Subchapter G and regulations adopted thereunder. The eastern boundary of the regulated area is as follows:

- (1) beginning at the intersection of State Highway No. 6 and Old San Antonio Road (OSR), which point is the north boundary line of Brazos County; thence in a southerly direction along OSR to its intersection with Texas Highway 21; thence in a westerly direction along Texas Highway 21 to the Little Brazos River; thence in a southerly direction along the east bank of the Little Brazos River to its intersection with the Brazos River; thence in a southerly direction along the east bank of the Brazos River to Koppe Bridge Road; commencing again at the railroad intersection on FM 159 in Allen Farm in a southerly direction along FM 159 to its intersection with State Highway 105.
- (2) Delete # 2, as there would no longer be any agricultural crop production requiring permit protection (it has been diverted into residential property uses).

This is the final step in the Commissioners Courts requirements. I have attached a copy of the TDA Regulated County procedures for your use and edification. If the Court votes to adopt the revisions, a letter will be forwarded to TDA requesting the change be published in the Texas Register, after which it becomes effective. We appreciate your efforts to ensure this process is completed.



How a County Can Become Regulated

This document outlines procedures for county officials to follow in order for a county to become regulated, deregulunder Chapter 76 of the Texas Agriculture Code, commonly referred to as the Texas Pesticide Law and Section 7.51 commonly referred to as the Texas Pesticide Regulations.

Instructions for becoming a regulated or deregulated county

When county officials become aware of interest in becoming regulated or deregulated, the county must hold a hear should be issued. Commissioners court orders to regulate or exempt a county from regulation that are issued under of the year following the date of the entry of the order. The commissioners court shall publish notice of the hearing held in at least one newspaper in the county. TDA officials may be available upon request to attend the county's puregarding what the county can and cannot do.

After the hearing, when the court of a newly regulated or deregulated county issues an order, the county must send the notice from the newspaper showing the date of publication directly to the Pesticide Programs Division, Texas Do 12847, Austin, Texas 78711. Along with the order, should be a request from the county that TDA add the county or or regulated counties. We request that this information be sent to the Austin headquarters as soon as possible.

When an order and letter from a newly regulated or deregulated county are received, TDA will send a letter to the order. After the order is issued, TDA will file any adopted changes with the **Texas Register**. The requesting county be provided copies of any **Texas Register** filings when published. The county should direct any questions regarding Austin.

Instructions for establishing special provisions

Under Section 7.51, regulated counties may establish special provisions to regulate the application of herbicides in apply to all or only a portion of the county. For example, if susceptible crops are only grown in a specific portion of regulated while the remainder of the county is deregulated. Examples of provisions counties may or may not establ Guideline for County Special Provisions.

When county officials become aware of interest in the adoption of special provisions for a regulated county, the conhearing to determine whether an order should be issued, and approval must also be obtained by TDA. If the county TDA may hold a public hearing upon receipt of the request. This public hearing may be held any time during the yellow publish notice of the hearing at least 10 days before it is to be held in at least one newspaper in the county. TDA of to attend the county's public hearing, to answer questions regarding what the county can and cannot do.

After the hearing, when the court issues its request for special provisions, the county must send a copy of the requests newspaper showing the date of publication directly to the Pesticide Programs Division, Texas Department of Agricul 78711. Along with the request should be a letter from the county that TDA review and approve the special provision court. We request that this information be sent to the Austin headquarters as soon as possible.

When a request from a county for special provisions is received, TDA will review the request and decide on its appr county acknowledging receipt and whether the request has been approved. After the approval letter is issued, TDA the **Texas Register** as proposed changes to the county's regulations or new county regulations. Once the comment prule adoption. The requesting county will be notified and provided copies of any **Texas Register** filings when publis questions regarding the order to TDA headquarters in Austin.

Instructions for establishing emergency exemptions

The dates for application of regulated herbicides may be extended for emergency situations upon the written requiregulated county and approval by TDA, if it is determined that an imminent threat to agricultural interests exists ir immediately addressed by a suspension of the department's rule a significant economic loss will result. This emerge with the **Texas Register** and the requesting county will be provided copies. The county should direct any questions headquarters in Austin.

- **1. Spray Permits** exemptions will not be allowed except during periods when susceptible vegetation is at through April 1).

- **5. Special Provisions Requiring TDA Personnel to Inspect Areas Prior to Treatments** special provisions r department to inspect land prior to spray permits being issued.
- 6. Regulate or Prohibit Methods of Application the department may consider a request to regulate or pr
- 7. Prohibit Application of any Regulated Herbicide During any Period of the Year The department may certain regulated herbicides which may cause adverse effects to susceptible crops or vegetation during a si
- **8. Exempt Portion of County from Regulations** The department may allow a portion of the county which recognizable physical boundaries to be exempt from provisions in 76.141-76.144.
