**A RESOLUTION TO AUTHORIZE THE CITY MANAGER, OR HIS OR HER DESIGNEE, TO ESTABLISH OR ADJUST GOLF FEES; SETTING MAXIMUM FEES; ALLOWING FOR ADJUSTMENTS RELATED TO WEATHER CONDITIONS, SPECIAL EVENTS, TOURNAMENT PLAY, PROMOTIONAL CAMPAIGNS, ANNUAL PASS DISCOUNTS, SENIOR/STUDENT DISCOUNTS, AND COMPETITIVE MARKET CONDITIONS; REPEALING ALL RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Bryan or contracted management company operates the City Course at The Phillips Event Center as a municipal golf course; and

**WHEREAS**, the City of Bryan or contracted management company staff is responsible for coordinating certain golf events and ensuring the number of rounds played are as high as possible at the City Course at The Phillips Event Center; and

**WHEREAS**, it is necessary to set certain fees for the reasonable use of golf facilities and coordination of activities; and

**WHEREAS**, some events, such as weather conditions, special events, tournament play, and market conditions, cannot be predicted; and

**WHEREAS**, it is necessary to adjust and set fees to reflect certain conditions affecting the fees and coordination of activities for the use of golf facilities, including The City Course at the Phillips Event Center.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRYAN, TEXAS THAT:**

**SECTION 1.**

Golf fees at the City Course at The Phillips Event Center shall be established and/or adjusted by the City Manager, or his or her designee. Fees may be adjusted for a number of reasons, including but not limited to weather conditions, special events, tournament play, promotional campaigns, annual pass discounts, senior/student discounts, or competitive market conditions. Fees may not be established or adjusted above the published fees as approved by the City Council, which are as follows:

**SECTION 2.**

All resolutions or parts of resolutions in conflict with the provisions of this resolution, including but not limited to Resolution 3844 are hereby repealed to the extent of such conflict.

**SECTION 3.**

This resolution shall be effective immediately upon adoption.
