Summary:

As part of the City of Bryan's Gateway Monument Project and as a requirement for the Interlocal Gateway Monument proposal submittal, the City (Local Entity) must provide TXDOT with an adopted resolution or other official documentation that describes the Local Entity's:

- 1. Jurisdiction over the area of the project site.
- 2. Approval of the Gateway Monument content.
- 3. Funding responsibility.
- 4. Commitment to ensure maintenance of the Gateway Monument (and any associated landscaping and/or lighting), including timely graffiti removal/repair, and removal (or restoration) of the Gateway Monument as needed.
- 5. Proposed schedule for commencing and completing project installation.

The attached Resolution covers these items and will be the first step in securing a gateway monument agreement with TXDOT.

Staff Analysis and Recommendation:
