AMENDMENT TO THE SCHOOL RESOURCE DEPUTY ITNERLOCAL AGREEMENT BETWEEN BRAZOS COUNTY AND THE COLLEGE STATION INDEPENDENT SCHOOL DISTRICT

THIS AMENDMENT TO THE SCHOOL RESOURCE DEPUTY INTERLOCAL AGREEMENT ("Amendment") is hereby made and entered into by and between BRAZOS COUNTY, TEXAS (hereinafter "County"), A political subdivision of the State of Texas, acting by and through its County Commissioner's Court and the COLLEGE STATION INDEPENDENT SCHOOL DISTRICT (hereinafter "CSISD"), a political subdivision of the State of Texas acting by and through its Board of Trustees, (referred to collectively as the "Parties").

WHEREAS, on March 24, 2022 the Parties entered into an Interlocal Agreement under the authority of Chapter 791 of the Texas Government Code to place School Resource Deputies in certain CSISD facilities; and

WHEREAS, the original Interlocal Agreement under Article IX section 9.2 allows for the Parties to amend the terms and conditions of the agreement so long as it is reduced to writing and signed by the duly authorized representative of both of the parties; and

WHEREAS, the Parties continue to recognize the outstanding benefits of the School Resource Deputy ("SRD") Program; and

WHEREAS, it is in the best interest of the Parties, the citizens of Brazos County, and the students of CSISD to continue the SRD Program and make modifications when appropriate based on changed circumstances.

NOW, THEREFORE IN CONSIDERATION of the recitals and mutual covenants made herein by the County and CSISD, the Parties hereby mutually agree to the following Amendments:

A.

ARTICLE IV SCHOOL ASSIGNMENTS

Section 4.1 shall have the following paragraphs added:

h. Two (2) SRDs to be designated as rover positions, to primarily act as a law enforcement presence, mentor, problem-solver, and provide positive police-student relations. These positions will provide additional presence on those campuses not covered by the ILA (elementary and intermediate schools) and assist with situations such as emergency drills; threat assessments; proactive patrols; and other situations based on the approval of BCSO command. Primary jurisdiction for these campuses will remain with the local authority (CSPD). SRDs may take calls for service on these additional campuses if they happen to be present/close by when needed. SRDs time at the elementary and

intermediate campuses will focus on engaging with students and staff in order to promote positive community-law enforcement relationships. These positions shall also be assigned as needed to support the needs of the SRU program and will be managed by the BCSO command.

ARTICLE VII SCHOOL District RESPONSIBILITIES

Section 7.2 Administrative Duties, shall be deleted and replaced with the following:

7.2 CSISD will provide all SRDs with access to an office that allows for security and privacy. The office must include, but is not limited to, a telephone, desk with lockable drawers, chair, office supplies, filing cabinet, which can be properly locked and secured, and computer. The location of each office shall be agreed upon by both BCSO and CSISD. The locations of the offices are subject to change as long as both parties agree on the placement of said offices.

All other terms and conditions shall remain the same.
