

Boat House

- 22' x 38' Boat house with two OH doors (Fisher Park was 18' x 30'). Boathouse should store 1 side by side utility vehicle and kayak trailer.
- (2) OH Doors one on each end
- Small climate-controlled cashiers office with transaction window and P.O.S. infrastructure
- Construction is anticipated to be metal framing with Hardie plank siding and a 4 ft brick wainscot to match Legends Event Center
- Storage for 10 12 single kayaks (Fisher had 9) and 7 10 double kayaks (Fisher Park had 7).
- Ample storage for kayaks, life jackets, safety equipment, etc.

Dock

- A floating EZ with Kayak Launch similar to that at Fischer Park in New Braunfels will be provided.
- A hose bid for domestic water is to be installed at the dock landing. Flexible connection/ PVC or semi-permanent hoses should bring water to the end of the dock.
- As of today dock is in stock. EZ Dock at current configuration roughly \$100K installed.

PBK Sports appreciates the opportunity to present our Proposal of Sports and Civil Engineering Services for the Beach Volleyball and Boathouse Facilities at the Bryan Midtown Park Sports & Event Center. Our understanding is that the Beach Volleyball facility is intended to be constructed to NCAA standards. Other work will include a turf lawn, athletic lighting, pedestrian lighting, low retaining walls, possible fencing and railing, concrete walkways, concrete boat ramp, grading and drainage, as well as a premanufactured pedestrian bridge and a floating dock. - · Periodic monitoring of construction operations.
- Perform final review of constructed improvements.
- Prepare TDLR review documents and assist with closeout documents.

Following are items which we will coordinate as part of our Scope of Services if necessary, but any fees or costs associated with each will be considered as reimbursable expenses.

Project Description

The construction of the City of Bryan's Legends Event Center is nearing completion. They are starting to focus on designing some of the site amenities surrounding the building. One of those amenities is a Boat House to store kayaks, boating supplies, a utility vehicle with trailer, and a climate-controlled cashiers office. The building will be approximately 850 sf. The project includes a prefabricated floating dock and sidewalk access.

Scope of Services

The Architect shall provide Architectural, Structural, and Mechanical/Electrical/Plumbing Engineering Services. This includes Schematic Design, Design Development, Construction Documents, Bidding/Negotiation/Permit and Construction Administration Services. Schematic design will be based on the owner provided "Program Notes" dated 08/12/22. Specifications will be provided to accompany the construction drawings, for use in defining the nature of materials and quality. Interim progress sets will be provided for Owner review and approval at the end of each phase. After each phase review, written approval of the work will be required prior to proceeding to the next phase.

The design work requires the knowledge of the conditions of the selected site. The Owner will provide a geotechnical report and survey of the site. Civil engineering is not included in this scope of work and will be provided by Mitchell and Morgan, the engineers for the overall development. Lighting will be provided along the pathway/pedestrian bridge to the dock as well.

Fee Proposal

We propose to provide architectural services for a fixed fee of \$43,000. The fee includes mechanical, electrical, plumbing engineering services by Cleary Zimmerman and structural engineering services by Dudley Engineering.

Reimbursable expenses are not included in this amount and will be invoiced at 1.15 times their actual expense incurred and will be justified by provision of records or receipts. Reimbursable expenses may include prints, copies, mileage/travel, survey, geotechnical report, Civil Eengineering, and Texas Accessibility Standards drawing review.

Additional Services, for work beyond the original scope, shall be based on the hourly rates as set forth in the attached rate sheets for each discipline. Additional Services will not be performed without written approval between the Owner and Architect.

Invoices will be sent monthly, proportionate to the work accomplished, and are payable within 30 days of the date of invoice. If not paid within 30 days, unpaid balances will accrue interest at a rate of 10% per annum or 0.833 per month.

We are excited about the project and are prepared to begin the work within 2 weeks, upon your acceptance of the terms of this Proposal.
