- As a part of our new legal advocacy initiative, we have partnered with attorney Shane Phelps to provide quality representation for former foster youth
- To date we have addressed multiple misdemeanor tickets to avoid and resolve warrants
- One client, with the assistance of Mr. Phelps, maintained compliance with her restrictions and was able to resolve her case without consequence
- One client obtained her necessary consular documents
- Multiple clients have received assistance from UP resolving tickets from their time in CPS care and dismissing these cases
- Multiple clients are working towards expunging their juvenile justice records, allowing an entirely clean slate and second chance

• A 20 year old female client entered the program in hopes she was approved for housing assistance. To her surprise, criminal charges from age 17 resulted in her denial from the HUD voucher program. With the assistance of her UP mentor and staff, she was able to address the charges, receive a dismissal, and reinstate her eligibility for housing. She is now in consistent housing, employed full-time, and working towards financial independence.

 An 18 year old female client entered the program 24 weeks pregnant, homeless, with no documents and nowhere to stay. Her family had kicked her out shortly after she moved in with them, and threw away all of her belongings. With UP's assistance, she has received emergency housing, prenatal and specialty medical care, obtained her legal documents and ID, has engaged in the housing process, began the enrollment process for junior college, and has opened her first bank account.

• A 19 year old participant decided to return to high school and change the direction of her life. She had been living a very dangerous lifestyle and was determined to not continue to be involved in that decision making. She attended her first day of school and with the help of UP staff located her classes and was introduced to the environment. She was so excited and proud to be able to say she was on her way to earning her diploma and living a life she thought had completely passed her by.

• A 19 year old client arrived at the office in the midst of a domestic violence crisis. She had been engaged in an altercation with her partner and needed help getting herself and her child to safety. Unlimited Potential assisted in transporting the mother and child to a safe location and connecting her with services.

OUR ENVIRONMENT


- Our office has become much more than an office.
- It is a place where youth can come vent their frustrations before they resort to old patterns of aggression and conflict
- It is a place where they can bring their children, ask for help, and have gentle parenting modeled
- It is a place where they can be completely honest about their struggles and receive non-judgmental support
- It is a place where they can laugh, cry, ask questions, build relationships, and grow
- It is a place where they learn to be adults, what they like to do, and who they want to be
- It is a place of decision making, advice, and steps towards a life they love
- The biggest limitation we have preventing this opportunity from being available to more youth is the ability to provide a supportive housing environment; with that, we would be able to connect these lessons and opportunities to a sense of "home"

"I really don't know what I would do without y'all. I have felt like a lost cause for so long but for some reason you seem to believe in me and that makes me want to keep going." -Participant, Age 24



I am glad I can tell UP when I am struggling and they will help me stay on track." -Participant, Age 20

Y'all have shown me that I can be more and do more." Participant, Age 20 "I don't want to be the same type of parent that mine were for me.Y'all have really helped me see that I can teach my child and not feel like I'm messing her up. I never want her to feel abandoned or worthless like I did." -Participant, Age 23
