As part of the 2021 bond program, the principals at Southwood Valley (SWV) and Pebble Creek (PC) Elementary Schools identified furniture for the summer 2023 renovation of classrooms.

The quotes from Educator's Depot Inc. are the result of several planning meetings with representatives from the district and the vendor. The quotes include shipping, assembly, furniture placement in rooms, and debris removal.

The pricing proposed by Educator's Depot Inc. is per the EPIC 6 Purchasing Cooperative Contract #16.20. This cooperative is administered by Education Service Center Region 6 and all items included in this contract were competitively bid and awarded by the Cooperative's Board of Trustees based on state statutes.

It is the recommendation of Carmella Shafer, Director of Purchasing to purchase the furniture, installation, and debris removal from Educator's Depot Inc. delivered and installed for \$360,831.22 using 2021 bond funds.
