Summary:

The City of Bryan entered into a Ground Lease Agreement with SMBG, LLC on November 15, 2022. As a result of ongoing design and development work by SMBG, LLC in strong coordination with City of Bryan staff and contractors for the construction of Road A, parking, and utility extensions, the Ground Lease Agreement requires amendment to modify certain Tenant Deadlines.

This proposed First Amendment to the Ground Lease Agreement adjusts several deadlines as follows:

1. Approval of Project Plans (Section 8.4.2)

a. Original: July 15, 2023

b. Proposed: September 15, 2023

2. Project Financing (Section 8.4.1)

a. Original: May 15, 2023

b. Proposed: November 1, 2023

- 3. Scheduled Project Start Date Milestone (Section 8.4.3)
 - a. Original: on or before August 15, 2023
 - b. Proposed: November 15, 2023
- 4. Substantial Completion Deadline (Page 17 of Appendix A)
 - a. Original: September 1, 2024
 - b. Proposed: December 31, 2024

Staff Analysis and Recommendation:

As with many large scale development project, design and development timing is fluid. SMBG and City staff, along with each entities designers and contractors, have put in many hours of work together to produce a quality project at Midtown Park. Staff is pleased with the progress and quality of the design underway, for both public infrastructure and private development. Staff recommends approval of this First Amendment to the Ground Lease Agreement. Modification of the Tenant Deadlines, as detailed herein, effectively delay project completion in total by 4 months.
