Description

Pecan Trails Elementary School

- ❖ Furnish and install appx 2,290 lf of 6' black coated chain link fence.
- ❖ 1-24' cantilever roll gate with knox box.
- ❖ 4-5' walk thru gates with panic bars.
- ❖ 1-5' walk thru gate with regular gate hardware.
- ❖ 1-12' double swing maintenance gate.
- ❖ Core Drill 5 holes thru existing concrete.
- ❖ Clear fence lines of brush as necessary. No tree removal.
- ❖ Includes 1 ditch crossing with extra corner posts and longer posts.

Demo existing vehicular gate. Cut off posts and fill holes with concrete. Add **\$850.00**

Cypress Grove Elementary school

- ❖ Furnish and install appx 3,875 lf of 6' black coated chain link fence.
- ❖ 1-25' double cantilever roll gate with knox box.
- ❖ 1-25' single cantilever roll gate with knox box.
- ❖ 2-5' walk thru gates with panic bars.
- ❖ 4-5' walk thru gates with regular gate hardware.
- ❖ Core Drill appx 30 holes thru existing concrete.


All Materials shall be heavy industrial grade, black coated.
Wire shall be 9 ga core wire woven in a 1" mesh, black coated.
All fences shall have a top and bottom rail.
All fence pipe shall be sps 40, heavy industrial grade, black coated.
Line posts shall be 2-3/8" od spaced 10 oc
End, corner and pedestrian gate posts shall be 3" od.
Cantilever roll gate posts shall be 4" od.

However, if, during the performance of this scope of work, the price of any required material significantly increases, through no fault of Bill's Fence Company, Inc., the customer will be required to acknowledge a change order to this quotation. The cost of the change order shall be reasonably necessary to cover any such significant price increases. This action shall only be enforced on any material in which Bill's Fence Company, Inc. has not been provided with enough information to release the materials for shipment prior to the increase (i.e. – lack of shop drawing or submittal approval, or etc.). A significant price increase shall mean any increase in price exceeding five (5%) percent from the date of issuance of the most recent quotation. Bill's Fence Company, Inc. agrees to provide the customer with vendor documentation supporting such material increases.

Unless an item is specifically listed as included, it is excluded from our quotation on the above project. The following items are specifically excluded from this quote: construction fence; demolition, excavation, or relocation of any existing work / utilities; final grading or clearing of fence lines; excavation of rock; hauling off of excess spoils; concrete other than post footings; mow strips; preparation of concrete test cylinders / concrete testing; grounding; attachments to fence; wind screens or privacy slats; layouts other than preset stakes; underground obstructions, running electrical lines or electrical work of any kind; discovery, relocation, or protection of any existing work, underground utilities or obstructions, property lines, water sprinkler systems, or landscaping; costs related to Owner / Contractor "project / job site specific" safety training or employee background review; engineered shop drawings; bond premiums; cost of subrogation. **The above items must be noted within the subcontractor agreement or purchase order accepted by Bill's Fence Company. Please let us know if you need any of the items listed in exclusions to be include within this quotation.**
