# **Statutory Item 6D**

## Design Contract For Old Reliance Road Widening April 8, 2024

## **Overall Scope**

#### Scope:

- Continuation of a previously completed expansion of Old Reliance Road from Earl Rudder Freeway to Austin's Colony Parkway.
- The general configuration includes a four lane divided road from Austin's Colony Parkway east to the City limits, approximately 3,650 linear feet of roadway.
- 10-foot shared use path on one side of the road to provide pedestrian access to Rudder High School.
- Analysis and Replacement of an existing culvert at the Carter's Creek crossing.
- Replacement of the sanitary sewer trunk line crossing Old Reliance Road.



## Request for Qualifications 24-008

Goodwin Lasiter Strong was selected through a Request for Qualifications process RFQ#24-008 and chosen as the most qualified to begin negotiations with out of 4 responding engineering firms. This project is in the approved Capital Improvement Projects 5-year Plan.

## **Proposed Scope**

The scope of work for the engineering design includes the following but is not limited to:

- Prepare construction plan and profile drawings for a new section of roadway for Old Reliance Road
- Prepare construction plan and profile drawings for the reconfiguring of the intersection at Austin's Colony Parkway and Old Reliance Road.
- Prepare construction details
- Prepare technical specifications as needed
- Prepare documents for proposal for construction of the project
- Construction of this project will primarily be funded from congressional appropriations. The design must account for all additional requirements for federally funded projects, including but not limited to: procurement requirements, contracting requirements/provisions, bonding requirements, and environmental impact assessments.
- Prepare cost estimates
- Submit LOMR and CLOMR to FEMA

- Fee provided by Goodwin Lasiter Strong for their typical scope of work is \$506,900.00 which equates to 7.35% of the engineer's opinion of construction cost estimate.
- Atypical services bring the total contract with GLS to \$648,300.00 or 9.4% of the EOPCC.
- Staff feels the fees proposed for this work are justified based on the additional scope of services discussed above.
