INDICTMENT

The Grand Jurors of Navajo County, Arizona, accuse **GLEN ANTHONY ESTRADA**, charging that in Navajo County, Arizona:

COUNT

ATTEMPTED SECOND DEGREE MURDER/DV, A CLASS 1 FELONY

On or about 2/12/2019, in the vicinity of Show Low, Navajo County, Arizona, **GLEN ANTHONY ESTRADA**, without premeditation, attempted to caused the death of V.H., in violation of ARS §§ 13-1104(A)(1), 13-1101, 13-1001, 13-901.03, 13-3601, 13-706, 13-704, 13-105(13), 13-701, 13-702, 13-801, a class 1 felony.

COUNT TWO

AGGRAVATED ASSAULT - DOMESTIC VIOLENCE, A CLASS 3 FELONY

On or about 2/12/2019, in the vicinity of Show Low, Navajo County, Arizona, **GLEN ANTHONY ESTRADA**, intentionally, caused serious physical injury to V.H., to wit: Caused Victim to have a stroke, and any of the circumstances exists that are set forth in §13-3601(A), paragraphs 1, 2, 3, 4, 5 or 6, in violation of ARS §§ 13-1204(A)(1), 13-1203(A)(1), 13-3601, 13-901.03, 13-706, 13-704, 13-105(13), 13-701, 13-702, 13-801, a class 3 felony.

**COUNT THREE
AGGRAVATED ASSAULT - DOMESTIC VIOLENCE, A CLASS 4 FELONY**


On or about 2/12/2019, in the vicinity of Show Low, Navajo County, Arizona,

GLEN ANTHONY ESTRADA, recklessly caused any physical injury to V.H. and intentionally or knowingly impeded their normal breathing or circulation of blood by applying pressure to the throat or neck or by obstructing the nose and mouth either manually or through the use of an instrument, and any of the circumstances exists that are set forth in §13-3601(A), paragraphs 1, 2, 3, 4, 5 or 6, in violation of ARS §§ 13-1204(B), 13-3601, 13-1203(a)(1), 13-701, 13-702, 13-801, a class 4 felony.
