



## TXDOT TO HOST OPEN HOUSE PUBLIC MEETING FOR SH 47 AT SH 21 INTERCHANGE PROJECT

Open house public meeting scheduled for November 14, 2024

November 6, 2024

**BRAZOS COUNTY** – The Texas Department of Transportation Bryan District in partnership with Brazos County are developing design concepts to reconfigure the SH 47 at SH 21 interchange and improve adjacent intersections along SH 47 and SH 21 in Brazos County, Texas. The proposed project would reconstruct the existing highways to four-lane divided highways with two lanes in each direction, separated by a concrete barrier. The improvements would also include adding two-lane, one-way frontage roads along the new highway interchanges, and the improvement of intersections within the project limits. The project limits extend from west of Fazzino Road along SH 21 to north of Thompsons Creek along SH 47, a distance of approximately 2.7 miles. The proposed project would require additional right-of-way at intersecting roadways and is not anticipated to displace residential or commercial businesses.

TxDOT and Brazos County are hosting an open house to introduce the project and to gather feedback from the local community. In-person participants are welcome to come and go any time from 4:30 to 6:30 p.m. and will be able to review project materials, ask questions of TxDOT and Brazos County staff and/or consultants, and leave written comments. On the day of the public meeting, the information presented will be made available online.
