EXCLUDED: All other employees, managerial employees, confidential employees, RNs employed by registries or other outside agencies providing labor to the Employer, guards and supervisors as defined by the Act. OTHERS PERMITTED TO VOTE: The parties have agreed that the House Supervisor RNs, House Supervisor Lead RNs, Infection Preventionists, Quality-Patient Safety Program Manager/s, National Nurse Resident Program Site Coordinator/s, Nurse Practitioner Critical Care, Nurse Practitioner Family Medicine, Nurse Practitioner Hospitalist, Nurse Practitioner Palliative Care employed by the Employer at its hospital campuses with their principal addresses currently located at 2801 Franciscan Drive, Bryan, Texas 77802 (“Bryan”); 1604 Rock Prairie Road, College Station, Texas 77845 (“College Station”); 210 South Judson Street, Navasota, Texas 77868 (“Grimes”); 100 West Cross Street, Madisonville, Texas 77864 (“Madisonville”); and 1101 Woodson Drive, Caldwell, Texas 77836 (“Burluson”) may vote in the election, but their ballots will be challenged since their eligibility has not been resolved. The eligibility or inclusion of these individuals will be resolved, if necessary, following the election.
